

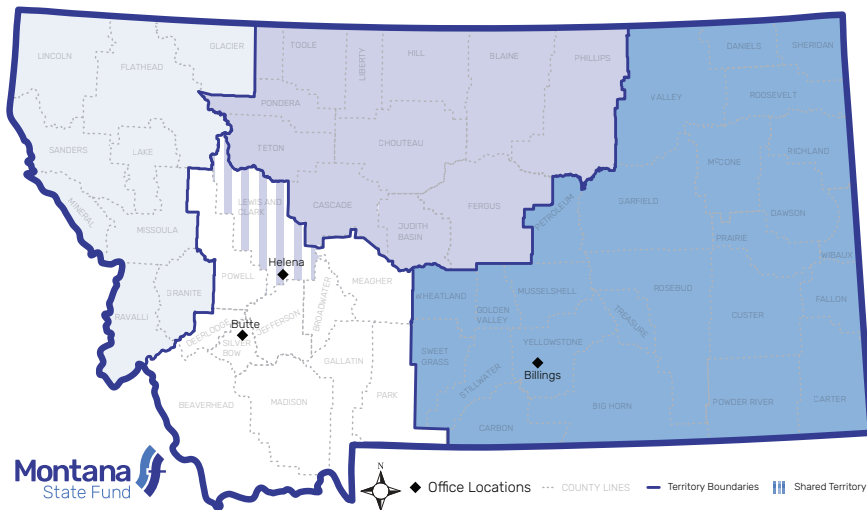

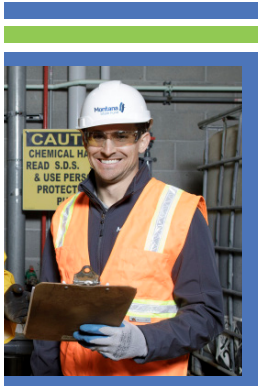


Dan Johnson

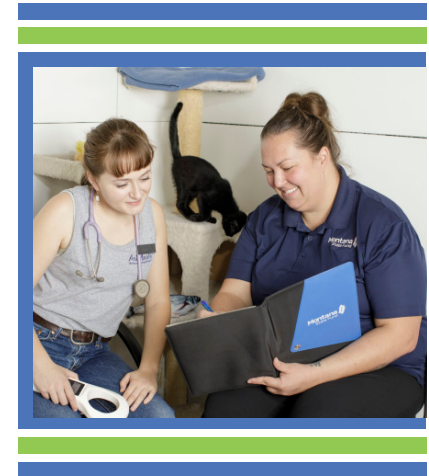


Ayla Marjamaa - West Territory

Safety Management Consultant

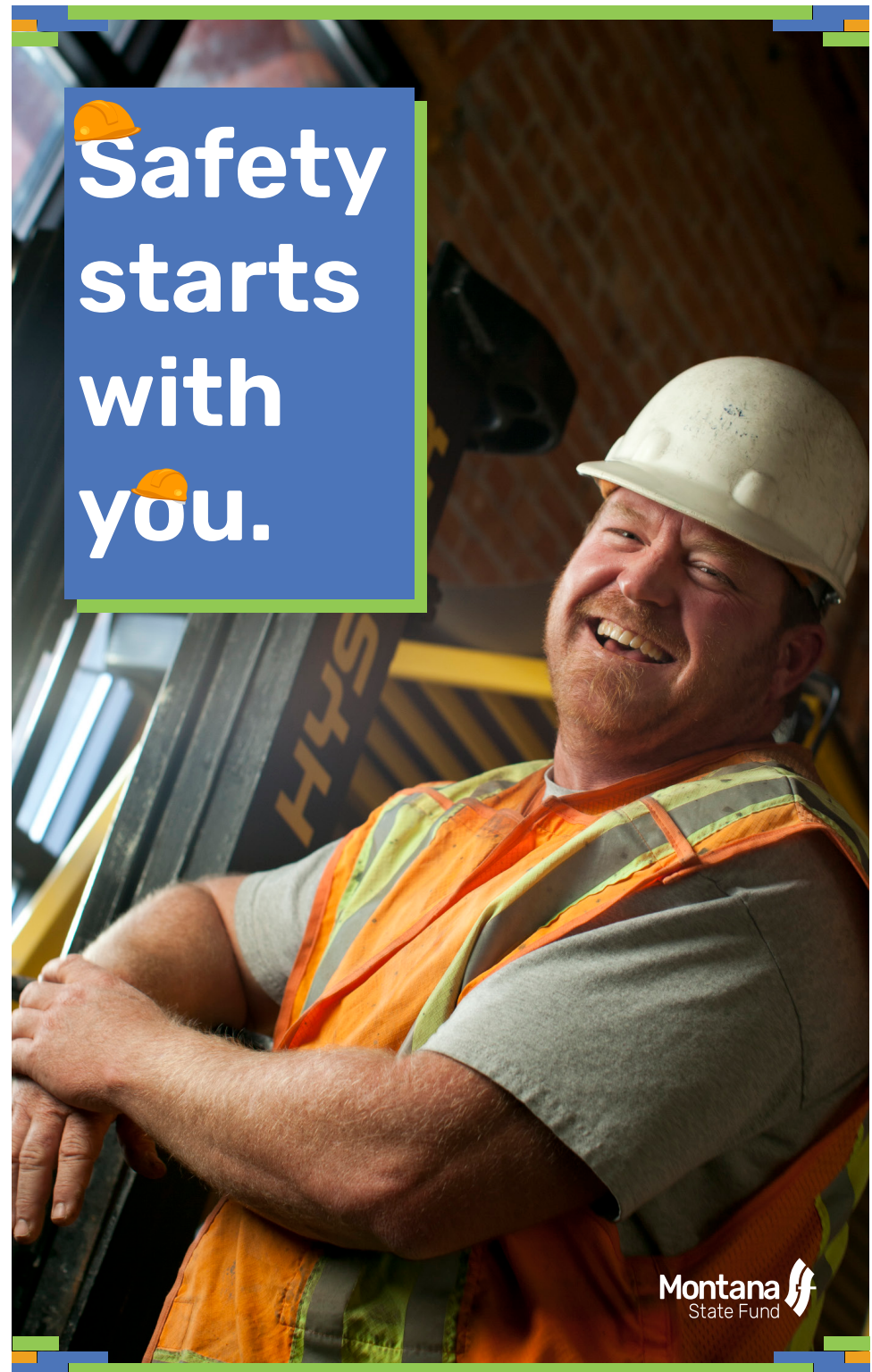
Danyel joined our staff in 2026. She has 20 years of safety experience in manufacturing environments where she enjoys collaborating to keep workers safe.
